#### **7.RESERVATIONS AND RELAXATIONS:**

**Relaxation of Marks:** 1<sup>st</sup> Class is relaxed to 2<sup>nd</sup> Class with 50% marks in aggregate for SC/ST candidates.

**Age Relaxation:** Upper Age limit as on 31.12.2020 should not be more than 30 years for General & EWS candidates. The upper age limit will be relaxed for SC, ST candidates by 5 years and for OBC candidates by 3 years. For candidates belonging to PWD category having minimum 40% disability or more, will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

The upper age limit is relaxed by 5 years for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir from 01.01.1980 to 31.12.1989.
